3. PROFILE OF SKILLS AND COMPETENCES
<p><u>Nursing measures:</u> Performance of the nursing tasks of nursing assistance level 1 on one's own responsibility without supervision (co-operation in nursing assessments; monitoring of the health status; performance of nursing tasks assigned by nurses to nursing assistants level 2 in line with their qualification profile; information, communication and assistance; co-operation in practical nursing assistance training level 1) as well as guidance and instruction of nursing assistants level 1 on order of a nurse.</p> <p><u>Activities in emergencies:</u> Recognition and assessment of emergencies and taking of appropriate measures and autonomous performance of life-saving emergency procedures if and as long as there is no doctor available, in particular: heart compressions and ventilation using simple respiration devices; defibrillation by means of semi-automatic devices or devices in the semi-automatic mode; administration of oxygen. A doctor of medicine has to be called immediately.</p> <p><u>Co-operation in diagnostics and therapy:</u> Performance of the tasks of nursing assistance level 1 on one's own responsibility without supervision (administration of medicines to be administered locally, transdermally as well as via the gastrointestinal and/or respiratory tract; administration of subcutaneous injections of insulin and anti-coagulants; standardised testing of blood, urine and stools as well as taking of blood from capillaries for point-of-care testing and performance of such tests; taking of blood from veins, excluding on children; administration of micro and single enemas; performance of simple wound care, including the application of dressings, compresses and bandages; tube feeding through an existing gastric tube; suctioning from the upper airways and the tracheostoma in stable situations of care; recording and monitoring of basic medical data (pulse rate, blood pressure, respiration, temperature, consciousness level, weight, height, excrements); simple measures of thermotherapy, cryotherapy and light therapy) as well as the following further tasks within the framework of the participation in diagnostics and therapy in individual cases according to a written medical order: performing standardized diagnostic programs such as ECG, EEG, BIA, lung function test; placement and removal of transnasal and transoral gastric probes; setting and removing transurethral catheters in women, with the exception of children; withdrawal and connection of continuous infusions, with the exception of cytostatics and transfusions with whole blood and/or blood components, with peripheral peripheral vascular access, maintenance of its continuity and, if necessary, the removal thereof; application of bodice, orthotics and electrically operated movement rails according to a given setting.</p>

<p>Additional information:</p> <p>Entry requirements: Successful completion of the tenth school grade or licence to exercise nursing assistance (level 1), medical fitness and trustworthiness; German language skills</p> <p>Duration of education and training: Two years/3.200 hours</p> <p>Theoretical instruction: min. 1.870 hours</p> <p>Thematic fields: Principles of professional nursing; nursing process (including EDP); target group- and setting-oriented relationship design and communication; principles of acute and long-term care including nursing technology; target group- and setting-oriented nursing including nursing technology; principles of medical diagnostics and therapy in acute and long-term care including medical care technology; target group- and setting-oriented medical diagnostics and therapy including medical care technology; cooperation, coordination and organization; development and assurance of quality; learning area Training and Transfer; module Written Thesis in the Subject Area</p> <p>Practical training: min. 1.060 hours Acute care; long-term care; target group-specific internship; internship at one's own choice; theory-practice transfer including reflexion on practice.</p> <p>The remaining rest of the hours in terms of total hours can be attributed to theoretical or practical training. This is intended to enable a special focus during education and training.</p> <p>Principles of education and training:</p> <p>Theoretical instruction: Orientation to situations and actions in discussing topics, issues and problems in training; learning from examples to give preference to developing and understanding basic principles and fundamental knowledge over frequently superficial knowledge transfer; consideration of the didactic principle "from simple to complex issues"; promotion of key competences as a prerequisite of the situation-specific application of professional competence in the fields of activities, including situational competence for actions in interpersonal relations; work in teams and small groups in order to practice skills and techniques, to reflect on attitudes, opinions, views, behaviours and experiences and to make them useful for further learning processes; consideration of principles of adult education; application of modern teaching, learning and examination methods; integration of theoretical and practical training to permit an optimal theory-practice transfer. In this context, it has to be ensured that within the framework of practical training, skills are only applied in patient care after the theoretical instruction relevant for the subject field in question.</p> <p>Practical training: The trainees are integrated in a team in practical training and actively participate in the relevant activities. To ensure an optimal theory-practice transfer, the guidance they receive in the course of traineeships is provided in agreement with and with continuous feedback to the course or school. This requires didactic preparation, implementation, follow-up, reflexion and evaluation. The competences acquired during practical training are documented by the trainees and signed off by teachers or healthcare professionals or the person responsible for training. Within the framework of practical training, the trainees are only assigned activities that are directly related to their training. Healthcare professionals may provide guidance to a maximum of three trainees at the same time in the course of practical training. A sufficient number of suitable in-service training places has to be ensured by appropriate arrangements, such as cooperation agreements or other suitable measures. An in-service training place is suitable if the acquisition of the competences planned for the traineeship in question is ensured. In planning and organising the traineeships, the objective is that practical training is provided at a minimum of two in-service training places. A traineeship must be at least 160 hours. Practical training during the night must be carried out with regard to the necessary acquisition of competences.
