3. PROFILE OF SKILLS AND COMPETENCES

Specialist areas of competence:

Concept development

The event management assistant has comprehensive knowledge of concept development and develops concepts for events based on the purpose of the event and customer needs. His/her tasks include the evaluation of customer briefings and the analysis of customer requirements. He/she selects suitable locations and external services and draws up cost and revenue plans. He/she involves colleagues and, where appropriate, subcontractors in his/her work.

Customer management

The event management assistant advises customers on operational services. Here he/she uses a rich repertoire of communication strategies and social skills. His/her tasks include processing customer enquiries, preparing offers and receiving and checking orders. He/she deals with complaints and claims competently.

Event management and implementation

Within the framework of event organisation, the event management assistant prepares event plans and opens up financing and funding opportunities. In addition, he/she checks whether the requirements regarding security and infrastructure at the venue are met. At the event, he/she coordinates communication between the people involved in the event and ensures that schedules are adhered to. After the event, the event management assistant deals with success monitoring and documentation.

Event marketing

The event management assistant has knowledge of marketing and develops marketing concepts for events based on this knowledge. He/she plans the specific media activities and participates in the design of operational communication media (e.g. newsletters, direct mailings, press releases, social media contributions/articles). In addition, he/she works on the workplace's external image.

Procurement

The event management assistant has knowledge of procurement, works on various tasks in this area and communicates with people inside and outside the workplace. In this way he/she determines the demand for services and goods in his/her area of responsibility, compares offers from different suppliers, makes a reasoned pre-selection and participates in the ordering of services or goods. He/she takes appropriate measures in the event of defective deliveries and services.

Office management

The event management assistant fulfils a variety of tasks within the scope of operational communication. This includes, in particular, letter or e-mail correspondence, where he/she takes care of the text design in accordance with internal specifications (e.g. corporate design). He/she undertakes schedule management and handles the incoming and outgoing mail. He/she uses the equipment of his/her work area competently.

Operational accounting

The event management assistant carries out work in operational accounting on the basis of his/her knowledge of the accounting system. In bookkeeping, this includes organisation of supporting documents and the checking of supporting documents. He/she is also involved in operational payment transactions. In addition, the event management assistant carries out tasks within the scope of data preparation (working with statistics and key figures).

Interdisciplinary areas of competence:

Working in an operational and professional environment

The event management assistant has basic knowledge of the operational range of services and of business, economic and ecological connections in order to organise and carry out his/her activities efficiently and sustainably. He/she acts self-competently, socially and methodically within the operational structure and process organisation and works on the tasks assigned to him/her in a solution-oriented manner appropriate to the situation based on his/her understanding of intrapreneurship. In addition, he/she communicates in a manner appropriate to the target group, also in English to suit the job, and acts in a customer-oriented manner.

Quality oriented, safe and sustainable work

The event management assistant applies the principles of operational quality management and is involved in the further development of operational standards. He/she reflects on his/her own approach and uses the knowledge gained from this in his/her area of responsibility. The event management assistant observes the legal and operational regulations for his/her personal safety and health at work and acts appropriately in the event of accidents and injuries. Within the scope of his/her area of responsibility, he/she considers significant ecological effects of his/her activity and therefore acts in a sustainable and resource-saving manner.

Digital work

The event management assistant selects and efficiently uses the most suitable digital equipment, operational software and digital forms of communication for his/her tasks within the framework of the legal and operational requirements. He/she digitally obtains the internal and external information necessary for the processing of tasks. The event management assistant acts purposefully and responsibly based on his/her digital competence. This includes in particular the sensitive and secure handling of data in compliance with legal and operational requirements (e.g. General Data Protection Regulation).

Legal basis

- 2. Curriculum framework (education at the vocational school for apprentices)

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

- 1. Training in the framework of the given training regulation for event management assistant and of the curriculum of the vocational school for apprentices. Admission to the final apprenticeship examination upon completion of the apprenticeship period specified for the apprenticeship trade concerned. The final apprenticeship examination aims to establish whether the apprentice has acquired the skills and competences required for the respective apprenticeship trade and is able to carry out the activities particular to the learned trade herself/himself in an appropriate manner.
- 2. Admission to the final apprenticeship examination in accordance with Article 23 (5) of the Berufsausbildungsgesetz (Vocational Training Act). An applicant for an examination is entitled to sit the final apprenticeship examination without completing a formal apprenticeship training if she/he has reached 18 years of age and is able to prove acquisition of the required skills and competences by means of a relevant practical or an on-the-job training activity of appropriate length, by attending relevant courses etc.

Additional information:

Entry requirements: successful completion of 9 years of compulsory schooling

Duration of training: 3 years

Enterprise-based training: Enterprise-based training comprises $^{4}/_{5}$ of the entire duration of the training and focuses on the provision of job-specific skills and competences according to Article 2 of the training regulation, BGBI. II (Federal Law Gazette) No. 54/2020, enabling the apprentice to exercise qualified activities as defined by the profile of skills and competences specified above.

Education at vocational school: School-based education comprises ¹/₅ of the entire duration of the training. The vocational school for apprentices has the tasks of imparting to apprentices the basic theoretical knowledge, of supplementing their enterprise-based training and of widening their general education in the framework of subject-oriented part-time instruction.
