3. PROFILE OF SKILLS AND COMPETENCES

- inspection and testing whether motor vehicles are in good running order, safe, reliable and roadworthy
- servicing of the vehicles
- systematic recognition and assessment of faults and failures of vehicles; repair of simple faults and failures
- steering of heavy goods vehicles, trucks, truck trailers and tractor trailers safely and skilfully, observing relevant provisions of motor vehicle and road traffic legislation and driving in a safe, economically efficient, environmentally conscious and considerate manner; provision of first aid
- proper behaviour in case of road accidents, other incidents and extraordinary situations to ensure that also any events with other involved people are covered
- handling of goods and substances during storage and transport
- loading, stowing and securing of goods
- route and time planning
- correct production and transmission of reports on damage, injuries and other events
- correct behaviour in cross-border goods transport including knowledge of required licenses and levied charges
- application of regulations governing goods transport
- customer-oriented behaviour and customer support
- anticipation of effects of factors influencing performance
- appropriate written and oral command of language and mode of expression as well as use of job-related foreign language

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (3)

Range of occupations:

Employment in areas of goods transport, rail and other transport companies in local and long-distance transport.

Qualifications pursuant to the 1994 *Gewerbeordnung* (Crafts, Trade, Service and Industry Act): The crafts, services and trades regulated on the basis of the 2002 Amendment to the *Gewerbeordnung* are subject to the provisions of the *Gewerbeordnung* on the furnishing of certificates of competency as contained in the respective regulations. Final apprenticeship examinations completed successfully replace, in particular, those parts of the master craftsperson examination which relate to subject-specific skills and competences in the various crafts and trades.

Legal basis

- 1. Training Regulation and Examination Regulation for Motor Vehicle Drivers *BGBI*. II (Federal Law Gazette) No. 190/07 (Federal Law Gazette)(enterprise-based training)
- 2. Curriculum framework (education at the vocational school for apprentices)
- 3. The present apprenticeship trade replaces the apprenticeship trade Motor Vehicle Driver (BGBI. [Federal Law Gazette] II No. 455/04), which expired as of 30 June 2007.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

- 1. Training in the framework of the given Training Regulation for Motor Vehicle Drivers and of the curriculum of the vocational school for apprentices. Admission to the final apprenticeship examination upon completion of the apprenticeship period specified for the apprenticeship trade concerned. The final apprenticeship examination aims to establish whether the apprentice has acquired the skills and competences required for the respective apprenticeship trade and is able to carry out the activities particular to the learned trade herself/himself in an appropriate manner.
- 2. Admission to the final apprenticeship examination in accordance with Article 23 (5) of the *Berufsausbildungsgesetz* (Vocational Training Act). An applicant for an examination is entitled to sit the final apprenticeship examination without completing a formal apprenticeship training if she/he has reached 18 years of age and is able to prove acquisition of the required skills and competences by means of a relevant practical or an on-the-job training activity of appropriate length, by attending relevant courses etc.

Additional information:

Entry requirements: successful completion of 9 years of compulsory schooling

Duration of training: 3 years

Enterprise-based training: Enterprise-based training comprises ⁴/₅ of the entire duration of the training and focuses on the provision of job-specific skills and competences according to Article 3 of the Training Regulation, *BGBI*. II (Federal Law Gazette) No. 190/07, enabling the apprentice to exercise qualified activities as defined by the profile of skills and competences specified above.

Education at vocational school: School-based education comprises $^{1}/_{5}$ of the entire duration of the training. The vocational school for apprentices has the tasks of imparting to apprentices the basic theoretical knowledge, of supplementing their enterprise-based training and of widening their general education in the framework of subject-oriented part-time instruction.
