## 3. PROFILE OF SKILLS AND COMPETENCES.

- handling of the operational business such as selling of shipping services and products, acceptance and delivery
  of shipments as well as proper recording of incoming and outgoing payments and checking the cash balance
- participation in determining demand, carrying out purchase orders and obtaining, processing and checking quotations, and checking order confirmations
- acceptance of shipments in the private and business customer segment and carrying out quantity and status checks of shipments
- commissioning of shipments, preparation of units suitable for dispatch and transport, and loading into different means of transport
- use of the company-specific means of transport and transport tools such as low-floor pallet trucks, roller containers, etc. and operation of industrial trucks and forklift trucks
- sorting of shipments for manual or mechanical further processing and processing of non-mechanically sortable shipments or sorting of shipments according to logistical aspects (trip route, trip planning, priority, quantity, etc.) as well as supply of shipments for mechanical sorting
- operation of sorting and conveying equipment, identification of faults and malfunctions and elimination of simple process disruptions
- adoption of measures in the event of distribution problems and in the detection of defects and damage to goods and packaging
- electronic recording of shipments requiring documentation and creation of a virtual delivery card
- management of delivery vehicles
- delivery, depositing and notification of shipments as well as execution of subsequent and return shipments
- informing and advising customers, conducting sales talks, dealing with complaints and offering services
- performance of the work taking into consideration relevant safety regulations, hygiene regulations, norms and environmental standards as well as distribution-related provisions
- appropriate written and oral command of language and specialist terminology as well as use of job-related foreign language

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

- Training in the framework of the given Training Regulation for Local and Distribution Logistics and of the curriculum of the vocational school for apprentices. Admission to the final apprenticeship examination upon completion of the apprenticeship period specified for the apprenticeship trade concerned. The final apprenticeship examination aims to establish whether the apprentice has acquired the skills and competences required for the respective apprenticeship trade and is able to carry out the activities particular to the learned trade herself/himself in an appropriate manner.
- 2. Admission to the final apprenticeship examination in accordance with Article 23 (5) of the *Berufsausbildungsgesetz* (Vocational Training Act). An applicant for an examination is entitled to sit the final apprenticeship examination without completing a formal apprenticeship training if she/he has reached 18 years of age and is able to prove acquisition of the required skills and competences by means of a relevant practical or an on-the-job training activity of appropriate length, by attending relevant courses etc.

#### Additional information:

Entry requirements: successful completion of 9 years of compulsory schooling

Duration of training: 3 years

**Enterprise-based training:** Enterprise-based training comprises <sup>4</sup>/<sub>5</sub> of the entire duration of the training and focuses on the provision of job-specific skills and competences according to Article 2 of the Training Regulation, BGBI. II (Federal Law Gazette) No. 197/2019 as amended by II 175/2024, enabling the apprentice to exercise qualified activities as defined by the profile of skills and competences specified above. (cf. job profile)

**Education at vocational school:** School-based education comprises 1/5 of the entire duration of the training. The vocational school for apprentices has the tasks of imparting to apprentices the basic theoretical knowledge, of supplementing their enterprise-based training and of widening their general education in the framework of subject-oriented part-time instruction.
